

SELECTMEN'S MEETING – October 15, 2012

Correspondence was read and acted upon.

The Select Board reviewed amended septic plans for:
Brown Family Revocable Trust Map 218, Lot 30
Larry & Judith Sawyer Map 218, Lot 57

The board was advised that there is new construction on the Turtle Ridge property on Streeter Pond Road. The owner will receive a letter notifying them that a building permit is required for all new construction. Map 207, Lot 10

The board was advised that there is new construction on the Ainsworth property located off Garnet Hill Road. The owners will be notified that they are in violation of the Town Zoning Ordinance and will be asked to come in and meet with the board. Map 210, Lot 10.

CHIEF WENTWORTH met with the board to update them on Police Department business and to discuss a complaint received by the department.

MR. STRASSER has been walking the Town boundaries with a representative from Cartographic Associates. They have been successful in finding the Easton/Franconia Sugar Hill corner and the Easton/Landaff/Sugar Hill sideline. The Bethlehem corner on Scragg Hill could not be located and the Lisbon corner off Streeter Pond will need to be done when the ground is frozen. They will be doing the top of Dyke Road this week.

MR. BIELEFIELD made a motion to hire Notchnet to replace Kernbuilt for the hosting of the Town website, seconded by MS. CONNORS. The motion was unanimous. The website will be changed back to Word Press by the end of the month and the Police Department site will also be updated.

The Select Board received a letter from the State of NH DOT – Bridge Division confirming that the Crane Hill Bridge is scheduled for 2022.

The board discussed a request from Rebecca Brown in regard wording on a statement for the Town Forest. Ms. Connors will follow up.

The Select Board reviewed the information from the Local Government Center in regard to the refunds that would be coming to the Town in the form of a Contribution Holliday. Both the Healthtrust and Property Liability Insurance will have refunds.
