

SELECTMEN'S MEETING – June 3, 2013

Correspondence was read and acted upon.

CHIEF WENTWORTH requested the board declare the Lupine & Fall Foliage Festivals as community events as they pertain to the Hawkers, Peddlers and Itinerant Vendors Ordinance. MR. STRASSER made a motion to declare the Lupine & Fall Foliage Festivals as community events as they pertain to the Hawkers, Peddlers and Itinerant Vendors Ordinance, seconded by MS.CONNORS. The motion passed unanimously. Chief Wentworth also updated the board on his meeting with PSNH representatives Roy Duddy and Randy Perkins. The Town has several options in regard to the streetlights including timers on non-intersection locations that could shut lights off at a designated time. The Chief also discussed placing ribbons on the poles that may be shut off so that residents could offer opinions.

The Select Board appointed Haley Ireland as the Deputy Health Officer for the Town of Sugar Hill.

The board signed a contract with Carl Dunn for the replacement of additional windows at the Crapo Building.

The Select Board discussed an application for a new garage for Milton Weiler, Map 214,
Lot 20. The setbacks will need to be verified on the side and from the center of the road. Mr. Weiler will be notified that there will need to be a survey and pins located on the side property line for an accurate measurement prior to a permit being issued.

MR. & MRS. PETKOVICH met with the board in regard to the reconfiguring of the intersection at Birches and Carpenter Road. The Petkovich's would like the Town to convey the newly created triangle so that the property deed can reflect the change in road frontage. The property in question is currently under contract and the new owner is concerned with the change of road frontage due to the Town changing the intersection.

MR. STRASSER will discuss with the Sugar Hill Planning Board on Wednesday evening and Attorney Waugh will be consulted.

MS. CONNORS made a motion to approve the minutes of May 20, 2013, seconded by MR. STRASSER. The motion passed unanimously.

With no more business and no appointments before the Board, MR. STRASSER made a motion to adjourn; seconded by MS. CONNORS the meeting was adjourned at 7:15 PM. The next regular scheduled meeting will be on Monday June 10, 2013 at the Carolina Crapo Building at 6:00PM.
